#### APPLICATION INSTRUCTIONS

#### SUBSTRATE PREPARATION

- Damage concrete must be repaired prior to application by using LANKO 731 REP STRUCTURE or a mortar mix with LANKO 751 LATEX.
- Surface must be clean, dry, free of dust, oil grease and any contaminations that could harm bonding.
- Use a metal brush to clean a concrete substrate.
- Use primer if the substrate is very porous.

#### **APPLICATION METHOD / TOOLS**

- Backing rod can be used to reduce joint depth.
- Use an adhesive tape to maintain the alignment.
- Cut off cartridge or foil pack seal of LANKO 603 POLY-URETHANE
- Insert cartride or foil pack of LANKO 603 POLY-URETHANE in the sealant gun.
- Cut nozzel to the desired bead size.
- Extrude LANKO 603 POLYURETHANE into the joint making sure that it cames into full contract with the sides of the joint and avoids any entrapment.
