SUBSTRATE PREPARATION

The substrate shall be thoroughly clean, free from dust, loose material, surface contamination and materials which reduce bond or prevent suction or wetting by cementitious materials. De-laminated, weak, damaged and deteriorated substrate shall be removed by suitable means before application. Rust, scale, dust and other loose and deleterious materials which reduces bond or contributes to corrosion shall be removed.

MIXING

Mix SikaLatex®-750 Bond with the correct amount of water to produce a gauging solution. Pour part of the gauging solution into a suitable mixing container. While stirring slowly, add the cementsand mix to the gauging solution and mix thoroughly until a smooth, uniform and lump-free mix is achieved. Within the mixing time add additional gauging solution to adjust to the desired consistency.

APPLICATION METHOD / TOOLS

Bonding Bridge/ Mortar

Thoroughly pre-wet the prepared substrate a recommended 2 hours before application. Keep the surface wet and do not allow to dry. Before application remove excess water e.g. with a clean sponge. The surface shall appear a dark matt appearance without glistening and surface pores and pits shall not contain water. Using a stiff clean brush work the mix vigorously onto the substrate, forming a thin layer filling all unevenness, pits and pores. Always apply following layer of mortar "wet on wet" onto bonding bridge.
